AHK World Conference 2023



After a five-year break, the AHK World Conference in May 2023 once again offered the AHK network a platform to foster and deepen the dialogue with each other and with its partners from German business, politics and science.

With internal formats for the future-oriented development of the AHK network and company-oriented cooperation between the Chambers of Commerce and Industry in Germany, IHKs, and AHKs, the conference was characterised above all by constructive discussions, innovative contributions and a strong sense of community among the participants. Highlights also included the festive evening with the award ceremony for German schools abroad and the World Economy Day under the motto “Supply chains, sustainability, energy crisis: Where does the German business model stand?”.

With a clear vision for a sustainable and competitive German economy, Vice Chancellor Dr. Robert Habeck underlined the importance of innovation and ecological transformation as well as the role of the German



Chambers of Commerce Abroad for the German economy. Siemens CEO Dr. Roland Busch emphasised the need for strong global partnerships in his convincing plea for cooperation and innovation.



Invited experts also discussed the German business model in times of de-coupling, de-risking and de-globalisation, new challenges and opportunities in supply chains and the positioning of Europe in trade and industrial policy. On the last day of the conference, the numerous present AHK honorary board members engaged in a direct exchange with State Secretary Dr. Jörg Kukies and BASF CEO Dr. Martin Brudermüller on current challenges in international business.

In this context, the AHK World Conference once again emphasized the crucial role of AHKs as bridge builders for German companies in increasingly complex global economic relations.

Highlights 2023



◀ **Compact with Africa – Expanding partnerships**

The largest German-African business conference on German soil took place on November 20th, 2023: Around 1,000 guests attended the 4th “G20 Investment Summit 2023 – German Business and the CwA Countries” in Berlin, which was organised by the Sub-Saharan Africa Initiative of German Business (SAFRI). In addition to Chancellor Olaf Scholz and Vice Chancellor Dr. Robert Habeck, it included ten African heads of state and government as well as around 30 ministers from the African continent. They were accompanied by over 300 business and political delegates, who met with representatives of the German economy in the afternoon. Colleagues from the AHK offices in Africa were also present and discussed important business-related topics concerning Africa’s political strategy with the guests of the summit.

GERMAN-UKRAINIAN ECONOMIC FORUM ON OCTOBER 24TH, 2023

Strengthening the reconstruction of Ukraine ▶

The Ukrainian economy is growing again, despite Russia’s ongoing war of aggression against Ukraine. Together with the German-Ukrainian Chamber of Commerce and Industry (AHK Ukraine) and the German Eastern Business Association (Ost-Ausschuss der Deutschen Wirtschaft, OA), the German Chamber of Commerce and Industry (DIHK) hosted the 6th German-Ukrainian Economic Forum on October 24th, 2023. Well over 500 guests from politics and business discussed the further expansion of bilateral economic relations between Germany and Ukraine as well as the reconstruction. The heads of government of both countries were present, and the Ukrainian president gave a welcome speech via video conference. All sectors of German companies were represented. The main focus was on infrastructure, energy, agriculture and security.



RECONSTRUCTION CONFERENCE TURKEY
ON JULY 13TH, 2023, IN THE HOUSE OF GERMAN ECONOMY

◀ German-Turkish commitment for reconstruction

On February 6th, 2023, several earthquakes shook south-eastern Turkey and parts of Syria. In order to ensure successful reconstruction, which will continue for years to come, an intensive commitment from the domestic private sector as well as abroad is crucial, in addition to international aid funds. The reconstruction conference on July 13th, 2023, at the House of German Economy was therefore held under the motto: “German-Turkish Conference: The role of the European private sector in (re)activating the economy in the regions affected by the earthquake”.

The event was organized by the Union of Chambers and Commodity Exchanges of Turkey (TOBB), the German-Turkish Chamber of Industry and Commerce (AHK Turkey), the Turkish-German Chamber of Commerce and Industry (TD-IHK) and DIHK. In addition to the “energy-efficient development of infrastructure”, the event focused, in particular, on the topic of “education”. AHK President Pinar Ersoy presented the idea of an “education bridge” at the conference, which is to be implemented by AHK Turkey together with DIHK starting 2024. The aim of the project is to open up new educational opportunities and, thus, future prospects for young people from the regions affected by the earthquake.

AHKS ON SITE IN GERMANY AT INTERNATIONAL TRADE FAIRS

Global economic relations revived by restarting of trade fairs ►

The international trade fair business experienced a new start in 2023 after the pandemic. At HANNOVER MESSE 2023 in April, the AHKs, together with DIHK and IHK Hannover, offered a varied programme on the Trade and Invest Stage and advised companies on opportunities in international business. At a joint booth with Germany Trade and Invest under the motto “AHKs & GTAI – worldwide under one roof”, they provided a central point of contact for visitors of the trade fair who wanted to learn about global market opportunities, innovative technologies and international business cooperation. Overall, AHKs were able to further strengthen bilateral economic relations between Germany and their host country through their presence at other trade fairs such as the International Toy Fair in Nuremberg, the International Green Week in Berlin and Anuga in Cologne.

STRENGTHENING GERMAN-IVORIAN ECONOMIC RELATIONS

Opening of the Delegation of German Industry and Commerce in Côte d'Ivoire

On June 26th, 2023, the Delegation of German Industry and Commerce in Côte d'Ivoire for the francophone West Africa was opened. Together with a delegation of German companies and institutional representatives as well as members of the German Parliament, DIHK CEO Dr. Martin Wansleben and State Secretary Anja Hajduk celebrated the festive occasion. An exchange with German company representatives, for example from the fields of road construction, medical test production and water and energy infrastructure in Côte d'Ivoire, rounded off the opening ceremony.



The three-day delegation trip also included visits to local production facilities and training centres, which serve as role models for German-Ivorian economic relations. Other important meetings on the agenda of the inaugural trip were the direct exchanges with German companies already active in Côte d'Ivoire, during which the framework conditions for trade and investment as well as specific business prospects were discussed.

The decision to open an office in Côte d'Ivoire reflects Germany's ongoing commitment to strengthen bilateral trade relations on-site while expanding the presence of German companies in global markets. Through its location in Abidjan, the Delegation provides a gateway for the German economy into the French-speaking part of West Africa.

CHALLENGING TIMES IN FOREIGN BUSINESS

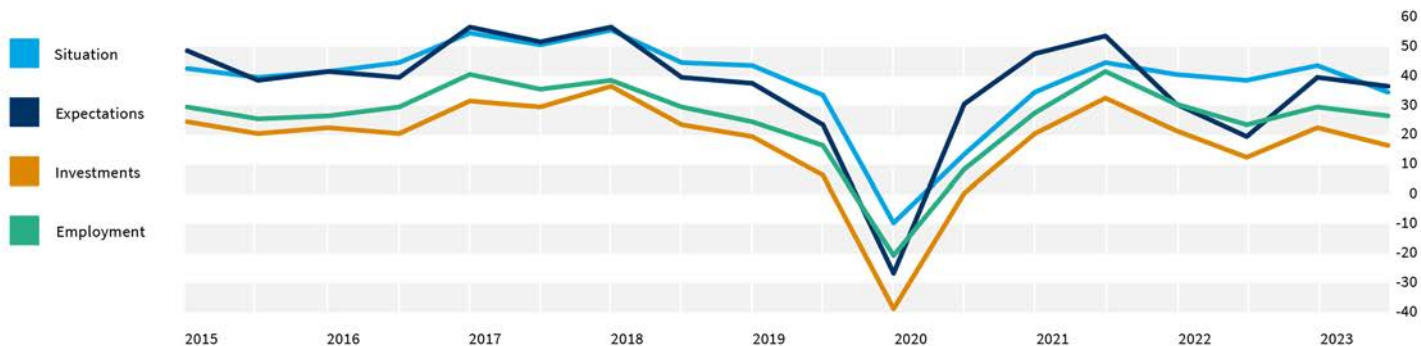
AHK World Business Outlook

How are German companies doing abroad? And how are they coping in international business? Twice a year, the AHK World Business Outlook analyses the business prospects of AHK member companies as well as their biggest risk factors and local economic developments. In spring and autumn 2023, a total of almost 9,000 companies worldwide took part in the surveys.

Even though German companies are resilient in global trade and have better business expectations on average at their international locations than at their German locations, the challenges in 2023 were considerable. In autumn 2023, companies at some locations were once again more gloomy about their future business prospects than in spring. In particular, low global demand, uncertain economic policy conditions and a shortage of skilled labour, which was lamented in many places, dampened the mood of the companies.

GERMAN COMPANIES ABROAD

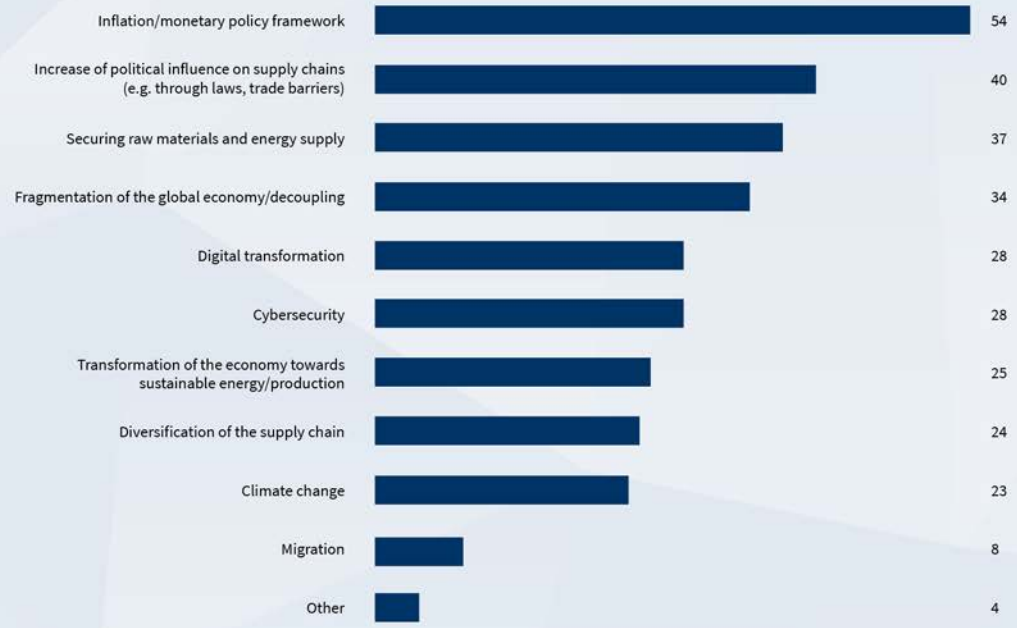
BALANCE OF “BETTER MINUS WORSE” REPORTS IN POINTS

The analysis of the AHK World Business Outlook also shows that geopolitical risks, higher interest rates and increasing trade barriers are making international business more difficult for German companies. While signs of fragmentation of the global economy into individual blocs can be seen, companies are nevertheless continuing to work on diversifying their supply chains and sales and procurement markets.

FOCUS TOPIC 2023

German Act on Corporate Due Diligence Obligations in Supply Chains

AWARENESS AND CAPACITY BUILDING FOR SUPPLIERS

The “German Act on Corporate Due Diligence Obligations in Supply Chains” was the buzz phrase for much of the German economy in 2023. Since its passing, the AHK network facilitated its communication and implementation abroad, offering advisory services and practical support for concerned companies and their partners.

After the Act entered into force, the AHK network has supported those businesses in the approach with the law – even if such activities eventually cannot provide legal certainty.

Local suppliers called on the AHKs in 2023 to enhance their understanding of due diligence requirements in Germany and attended local and online awareness events as well as in-depth training. The AHKs India, Ghana, Southern Africa and Mexico are just some good examples of AHKs which were able to develop, with GIZ financing, in-house training solutions for this target group.

Other AHKs which offer broad services tailored to the Act include Colombia, Malaysia, Vietnam and Hong Kong.
